

# SUNET TCS eScience Personal Certificate Service

## Subscriber Registration Form

This form is used to register a SWAMID member organization with the SUNET TCS eScience Personal Certificate Service. The form must be signed by a person that can legally represent the organization ("firmatecknare").

The approved SWAMID membership application for the Subject must already include a description of the identity management procedures which satisfy the requirement of the TCS eScience Personal CPS. The Subscriber must review recommendations and implement suitable technical controls described at this URL:

## ***Subscriber Agreement***

1. The Subscriber must be a SWAMID member and a SUNET connected organization in order to be eligible for the TCS eScience Personal Certificate service.
2. The Subscriber is responsible that its staff and representatives involved with the TERENA eScience Personal Certificate Service (TCS eScience Personal) read and understand the terms and conditions in the TCS eScience Personal Certificate Practice Statement (CPS) and associated policies that are published in the TCS repository at <http://www.terena.org/tcs/repository/>. The Subscriber agrees with these terms and conditions.
3. The Subscriber shall follow the practices and procedures described in the CPS, and shall act in accordance with the conditions imposed on Subscribers by the CPS.
4. The Subscriber is responsible to use TCS eScience Personal certificates only for legal and authorized purposes in accordance with the suggested usages and practices in the CPS. In particular, Subscriber shall not use certificates for securing credit card transactions, online payments or other monetary transactions.
5. The Subscriber shall not install and use an issued certificate until after the Subscriber has reviewed and verified the accuracy of the data in the certificate. Subscriber is responsible to cease using a certificate if any information in it becomes misleading, obsolete or invalid.
6. The Subscriber is responsible to provide correct and accurate information in its communications with SUNET. Subscriber is responsible to alert SUNET if at any stage while a certificate is valid, any information originally submitted has changed since it had been submitted to SUNET.
7. The Subscriber is responsible to make reasonable efforts to prevent the compromise, loss, disclosure, modification or otherwise unauthorized use of the private key corresponding to the public key published in a certificate. Subscriber is responsible to request the revocation of a certificate in case of an occurrence that materially affects the integrity of a certificate.
8. Certificates issued to Subscriber may be revoked by SUNET or TERENA according to the conditions indicated in the CPS.
9. The Subscriber is responsible to cease using a certificate if it has expired or has been revoked.
10. the Subscriber is responsible for revoking certificates belonging to any user that for any reason has been removed from the Identity Provider or has had his/her status changed in a way that affects TCS eScience Personal.
11. The Subscriber is responsible to obey the applicable law with respect to each certificate.
12. The Subscriber is responsible for establishing and maintaining technical controls in order to comply with the identity management requirements described in the CPS.
13. The Subscriber will immediately notify SUNET if an Administrative Contact should cease to be authorized to access the SUNET TCS Certificate Portal application.
